Executive Summary:

Income slightly higher than budget expectations due to higher pledge/plate offerings for MTD. A review is underway to understand the current pledges vs. plate offerings.

Our budget assumes \$540K in pledge, we do, currently, have a gap.

Expenses essentially within budgeted expectations with a few exceptions due to timing plus the continued higher maintenance costs this year associated with the boiler repairs.

Audit Update:

2018 we will have a review audit (similar to 2016). The files have been sent and Sylvia will be working with MIchelle in the June timeframe.

Some sorting still needs to be done between plate & pledge - still working on that, administratively
